TOUR COSTS

This tour is priced in NZ dollars to accommodate any fluctuations in exchange rates. The final cost of the tour will be calculated in New Zealand dollars and advised once deposit is received and bookings are confirmed. All payments are to be made in New Zealand dollars.

DEPOSITS AND FINAL PAYMENTS

A non-refundable deposit of 10% is payable on confirmation. Balance of payment is due to Playing Around New Zealand Limited no later than 30 days before tour travel. In the unlikely event that you have to cancel Playing Around New Zealand Limited will endeavour to discuss with you any alternative tour programmes. Payments by bank transfer must include all bank transfer cost at clients cost. Full amount as per invoice must be received by Playing Around New Zealand Ltd.

CANCELLATION

Should you cancel your booking the following cancellation charges will apply:

More than 30 days prior to departure - loss of deposit or transferred to another golf tour by agreement.

Inside 30 days - up to 100%*
